PURPOSE This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product:

US Dollar Class (Retail) (ISIN IE000JG3I083) (the "Class") is a share class of Polen Capital Emerging Markets Growth Fund (the "Fund") a sub-fund of Polen Capital Investment Funds plc (the "Company")

This PRIIP is authorised in Ireland and regulated by the Central Bank of Ireland. The PRIIP Manufacturer and the Management Company is Amundi Ireland Limited (the "Manager") which is authorised in Ireland and supervised by the Central Bank of Ireland. Polen Capital UK LLP is the Sub-Investment Manager appointed to the Fund.

WHAT IS THIS PRODUCT?


The Class is a share class of the Fund which is a sub-fund of the Company, an open-ended umbrella investment company with variable capital and segregated liability between Funds incorporated with limited liability in Ireland under the Companies Act 2014 with registration number 522617 and established as an undertaking for collective investment in transferable securities pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations, 2011 (S.I. No. 352 of 2011), as amended (the "UCITS Regulations").

Subject to the conditions set down in the Prospectus, investors may switch their shares in the Fund or Class for shares in a different class of the Fund or another Fund or Class. Please refer to the section entitled "Conversion of Shares" in the Prospectus and Fund Supplement for further details. The Prospectus of the Company and the periodic reports are prepared for the entire Company. There is no fixed term for this Fund.

The Fund will invest primarily in a well-diversified portfolio of common stock of companies whose shares are listed or traded on Recognised Exchanges globally which have substantial business in, or revenues from, Emerging Markets as well as the equity securities of issuers in Emerging Markets which have a predominant proportion of their assets or business operations in Emerging Markets. For the avoidance of doubt, such investments may include investment in China A-Shares of companies in the People's Republic of China ("PRC"). The Sub-Investment Manager will transact China A Shares listed on the Shanghai Stock Exchange ("SSE") and Shenzhen Stock Exchange ("SZSE") mainly through the Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect programs (collectively, the "Stock Connects"). The Fund may invest in and have direct and indirect access (through for example Global Depositary Receipts, American Depositary Receipts and International Depositary Receipts) to certain eligible China A Shares and China B Shares listed on the SSE and SZSE via the Stock Connects. The Fund may also invest in China H Shares issued by companies which are incorporated in the PRC and trade on the Stock Exchange of Hong Kong ("SEHK"). The anticipated maximum direct investment in Chinese securities, which are listed or traded on the SSE, SZSE, or SEHK, is 60% of the Net Asset Value of the Fund. However, while this is the anticipated maximum exposure; this maximum may be exceeded as a result of matters outside of the Investment Manager's control, which may include, for example, market movements. The Fund may invest up to 30% of net assets in Russian securities which are listed or traded on Recognised Exchanges including the Moscow Exchange. The Fund may also invest in global depositary receipts, American depositary receipts, European depositary receipts, and international depositary receipts where deemed appropriate by the Sub-Investment Manager in order to achieve the investment objective of the Fund. These stocks are selected by the Sub-Investment Manager on the basis that they operate with a sustainable underlying competitive advantage among Emerging Market companies, in their respective industries or sectors. For example, the Sub-Investment Manager will select Emerging Market securities , which it feels have consistent and sustainable high returns on capital, vibrant earnings growth, robust free cash flow generation, strong balance sheets and competent and shareholder-oriented management teams. The Fund may also hold and maintain ancillary liquid assets, including cash and cash equivalents (such as certificates of deposit) and money market instruments (such as commercial paper, bankers acceptance and other short-term debt securities). The Fund may also invest in and gain exposure to Indian securities. The Fund may use a limited number of simple derivative instruments for hedging purposes (such as currency swaps and currency forwards). It is not intended that the Fund will be leveraged as a result of its use of derivatives. The Fund is considered to be actively managed in reference to MSCI Emerging Markets Index (the "Benchmark") by virtue of the fact that it uses the Benchmark for performance comparison purposes. Certain of the Fund's securities may be components of and may have similar weightings to the Benchmark. However the Benchmark is not used to define the portfolio composition of the Fund or as a performance target and the Fund may be wholly invested in securities which are not constituents of the Benchmark. The Shares that you will hold in the Fund are accumulating Shares. This means that income from the Fund's investments will be included in the value of your shares rather than being paid to you as a dividend. You may sell shares in the Fund by submitting an application to the Fund's Administrator before 2 p.m. (Irish time) on any Business Day and/or such other day or days as may be determined by the Directors of the Company. The Company's depositary is The Bank of New York Mellon SA/NV, Dublin Branch. The intended retail investor is those who are seeking long-term capital appreciation, have a long-term investment horizon, are willing to accept a moderate to high level of volatility and are willing to invest through a complete market cycle.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MY MONEY OUT EARLY?

The recommended holding period of 5 years is based on the liquidity profile of the Fund as well as the risk profile of the underlying assets.

In order to divest/redeem from the Class you can send a completed signed redemption request in the form available from the Administrator in accordance with the provisions of the Supplement for the Fund outlined in the section entitled "Redemption of Shares" prior to 2p.m. (Irish time) on any Business Day (as defined in the Prospectus). and/or such other day or days as may be determined by the Directors of the Company.

If the number of shares to be redeemed on any Dealing Day (as defined in the Supplement) exceeds at least 10% of the total number of shares of the Fund in issue on that day or 10% of the NAV of the Fund, the Directors may refuse to redeem any shares in excess of 10% of the total number of shares of the Fund in issue or 10% of the NAV of the Fund, as further described under the sub-heading "Redemption Gate" in the Prospectus. If the redemption of only part of a shareholder's shareholding would leave the shareholder holding less than the Minimum Holding for the Fund, the Company or the Administrator may, if it thinks fit, redeem the whole of that shareholder's holding. Please refer to the section of the Prospectus entitled "THE SHARES" – "Redemption of Shares". While it is not the current intention of the Directors to charge a redemption fee. However, in order to prevent excessive and disruptive trading practices the Directors may impose a redemption fee not exceeding 3% of the NAV of SharesNet Asset Value of shares being redeemed for the benefit of the Fund. Please refer to "What are the costs" above the section of the Supplement entitled "Redemption of Shares" – "Redemption Fee".
