Objectives and Investment Policy

The Fund's objective is to achieve long term growth of capital.

The Fund will invest primarily in a well-diversified portfolio of common stock of companies whose shares are listed or traded on Recognised Exchanges globally which have substantial business in, or revenues from, Emerging Markets as well as the equity securities of issuers in Emerging Markets which have a predominant proportion of their assets or business operations in Emerging Markets.

The Fund may also invest in global depositary receipts, American depositary receipts and European depositary where deemed appropriate by the Investment Manager in order to achieve the investment objective of the Fund. The Fund will invest primarily in a focused portfolio of common stock of companies whose shares are listed or traded on Recognised Exchanges globally which have substantial business in, or revenues from, Emerging Markets as well as the equity securities of issuers in Emerging Markets which have a predominant proportion of their assets or business operations in Emerging Markets. globally which have substantial business in, or revenues from, Emerging Markets as well as the equity securities of issuers in Emerging Markets which have a predominant proportion of their assets or business operations in Emerging Markets. For the avoidance of doubt, such investments may include investment in China A-Shares of companies in the People's Republic of China (“PRC”). The Sub-Investment Manager will transact China A Shares listed on the Shanghai Stock Exchange (“SSE”) and Shenzhen Stock Exchange (“SZSE”) mainly through the Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect programs (collectively, the “Stock Connects”). The Fund may invest in and have direct and indirect access (through for example Global Depositary Receipts, American Depositary Receipts and International Depositary Receipts) to certain eligible China A Shares and China B Shares listed on the SSE and SZSE via the Stock Connects. The Fund may also invest in China H Shares issued by companies which are incorporated in the PRC and trade on the Stock Exchange of Hong Kong (“SEHK”). The anticipated maximum direct investment in Chinese securities, which are listed or traded on the SSE, SZSE, or SEHK, is 60% of the Net Asset Value of the Fund. However, while this is the anticipated maximum exposure; this maximum may be exceeded as a result of matters outside of the Investment Manager's control, which may include, for example, market movements. The Fund may invest up to 30% of

net assets in Russian securities which are listed or traded on Recognised Exchanges including the Moscow Exchange.

The Fund may also hold and maintain ancillary liquid assets, including cash and cash equivalents (such as certificates of deposit) and money market instruments (such as commercial paper, bankers acceptance and other short-term debt securities).

The Fund may also invest in and gain exposure to Indian securities.

The Fund may use a limited number of simple derivative instruments for hedging purposes (such as currency swaps and currency forwards). It is not intended that the Fund will be leveraged as a result of its use of derivatives.

The Fund is considered to be actively managed in reference to MSCI Emerging Markets Index (the “Benchmark”) by virtue of the fact that it uses the Benchmark for performance comparison purposes. Certain of the Fund's securities may be components of and may have similar weightings to the Benchmark. However the Benchmark is not used to define the portfolio composition of the Fund or as a performance target and the Fund may be wholly invested in securities which are not constituents of the Benchmark.

The Shares that you will hold in the Fund are accumulating Shares. This means that income from the Fund's investments will be included in the value of your shares rather than being paid to you as a dividend.

You may sell shares in the Fund by submitting an application to the Fund's Administrator before 2 p.m. (Irish time) on any business day and/or such other day or days as may be determined by the Directors of the Company.

Recommendation: this Fund may not be appropriate for investors who do not have a long-term investment horizon.

The value of the Fund can go up and down more often and by larger amounts than funds that invest in developed countries, especially in the short term.
