

## KEY INVESTOR INFORMATION

This document provides you with key investor information about this fund. It is not marketing material. The information is required by law to help you understand the nature and the risks of investing in this fund. You are advised to read it so you can make an informed decision about whether to invest.

**Polen Capital Global SMID Company Growth Fund (the “Fund”) a sub-fund of Polen Capital Investment Funds plc (the “Company”)**

**A Class (Retail) (ISIN IE000SJR2ZG7) (the “Share Class”)**

### Objectives and Investment Policy

The Fund's objective is to achieve long term growth of capital. The Fund will invest in a focused portfolio of global equity securities of small and mid cap companies (market capitalisations within the range of the market capitalisations of companies in the MSCI ACWI SMID Cap Index (the “Benchmark”) at the time of purchase) which are listed, traded or dealt in or on global Recognised Exchanges. The Fund may also invest in common stocks of companies, whose shares are listed or traded on Recognised Exchanges, outside of the above-mentioned market capitalisation where the stock represents an attractive investment opportunity.

The Fund's investment in developing or Emerging Markets will not exceed 30% of its Net Asset Value. The Fund may invest up to 10% of its Net Asset Value in Russian securities which are listed or traded on the Moscow Exchange. As part of the Fund's investment in Emerging Markets the Fund may invest in Indian securities.

The Fund may also invest in global depositary receipts, American depositary receipts and European depositary where deemed appropriate by the Investment Manager in order to achieve the investment objective of the Fund.

The stocks of small and mid cap companies are selected by the Investment Manager on the basis that they are high quality. For example the Investment Manager will select companies that can demonstrate real organic revenue growth high returns on invested capital and on equity, stable to improving margins, robust free cash flow generation, strong balance sheets and competent shareholder-oriented management teams.

The Fund may also hold and maintain ancillary liquid assets, including cash and cash equivalents (such as certificates of deposit) and money market instruments (such as commercial

paper, bankers acceptance and other short-term debt securities). Investment in such ancillary liquid assets will typically not exceed 10% of the Net Asset Value of the Fund.

The Fund may also invest up to 10% of its Net Asset Value in aggregate in other open-ended collective investment schemes which have investment policies similar to those of the Fund.

The Fund may use a limited number of simple derivative instruments for hedging purposes (such as currency swaps and currency forwards). It is not intended that the Fund will be leveraged as a result of its use of derivatives.

The Fund is considered to be actively managed in reference to the Benchmark by virtue of the fact that it uses the Benchmark to define the characteristics of the securities held by the Fund. Certain of the Fund's securities may be components of and may have similar weightings to the Benchmark. However, the Fund may be wholly invested in securities which are not constituents of the Benchmark. The Fund may also use the Benchmark for performance comparison purposes, however it is not used as a performance target.

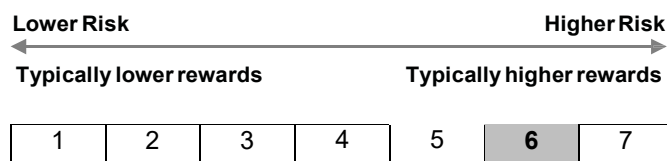
The Shares that you will hold in the Fund are accumulating Shares. This means that income from the Fund's investments will be included in the value of your shares rather than being paid to you as a dividend.

You may sell shares in the Fund by submitting an application to the Fund's Administrator before 2 p.m. (Irish time) on any business day and/or such other day or days as may be determined by the Directors of the Company.

Recommendation: this Fund may not be appropriate for investors who do not have a long-term investment horizon.

### Risk and Reward Profile of the Fund

**Securities risk:** some of the markets or exchanges on which the Fund may invest may go up and down, and value of your investment may not increase.

**Emerging Markets risk:** countries where investment markets are considered to be less developed. Investments are generally riskier than those in developed markets because they: may not be as well regulated and laws may be less sophisticated, may be more difficult to buy and sell, may have less reliable arrangements for the safekeeping of investments, or may be more exposed to political and taxation uncertainties. The value of the Fund can go up and down more often and by larger amounts than funds that invest in developed countries, especially in the short term.

## Charges for the Fund

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.
